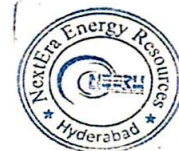

1. NEERU will collect dry recyclable waste and old records from college and bring to their facility without any spillage.
2. NEERU will organize sorting of the dry waste into different categories baling, and appropriate disposal of Wet Waste convert into biomethanation process for using cooking fuel.
3. NEERU shall undertake necessary measures for dispatch of the sorted recyclables for recycling at its own cost.
4. E- waste will be recovered by NEERU authorized partnering company and safely dismantle / discard the waste.
5. 
