### Policy Circular on Disabled Friendly barrier Free Environment

As per the general body meeting held on 03-07-2017, the management is decided to provide the following facilities for Disabled Friendly barrier free environment in the Institution.

- 1. Built environment with ramps & lifts: -In order to facilitate the Divyangjan for access to class room, lift with a carry capacity of 4 members may be installed. Apart from the lift arrangement, ramps construction at main entrance and all labs on the ground floor are required to be completed immediately.
- 2. **Divyangjan friendly washrooms**: Divyangjan friendly wash rooms with Western style lavatories wheels chairs and walker are required to be provided.
- 3. **Display Board & Sign Posts for tactile paths**: -Tactile paths way to the additional building blocks from main block along with lights, display boards are required to be provided.
- 4. Separate screen reading Software or Lipi should be procured and keep in the college.
- 5. Suitable reception counter with human assistance or scribe and screen reading material should be setup.

### **Policy for Scribe**

Guidelines for use of scribe/paper writer for visually handicapped/orthopedically handicapped students:

In the case of students who are eligible for availing the services of scribes, the Principal shall authorize to appoint scribes according to the following conditions.

- The scribe shall not be an employee of the college/centre where the examinations conducted. The scribe shall not be a relative of the student who is appearing for the examination. The educational qualifications of the scribe shall be less than those of the student.
- A pro forma with declaration in the format given institute shall be obtained from the scribe.
   The pro forma signed by the scribe shall be forwarded to the institute.
- The Government of India has notified guidelines for evaluation of the disabilities and procedures to be adopted at Higher Educational Institutions.
- The institution as per the guidelines of the government and that of the affiliating university will ensure that the persons with disabilities are encouraged.
- Both the student as well as scribe will have to give an undertaking as per the format attached (Annexure-V), that the scribe fulfills the stipulated eligibility criteria. In case, if it later transpires that the scribe did not fulfill any of the laid down eligibility criteria all the examinations the scribe wrote for the student shall stand cancelled.

The word DIVYANGJAN refers to (United Nations Convention on the Rights of Persons with Disabilities): Persons with disabilities include those who have long-term physical, mental, intellectual or sensory impairments that, in interaction with various barriers, may hinder their full and effective participation in society on an equal basis with others.

### **Objective**

To establish a positive environment and quality education to improve the academic performance of differently – able students and to assure essential guidance and counseling to support them.

### Polices and measures:

- Providing suitable facilities to the differently able students in the institution.
- Scribe facility is provided with the remuneration of Rs.200 per course.
- NVDA and JAWS software are installed for the visually impaired students in the Central Library.
- Helpline numbers are provided exclusively for the Divyangians to reach out for any kind of
  assistance inside the campus. Offering support in processing special scholarship from the
  Government.
