Step 6: Training Certificate to be obtained from industry.

Step 7: List of students who have completed their internship successfully will beissued by FacultyMentor and the same should be maintained by the respective department (III Coordinator).

Internship Report: After completion of Internship, the student should prepare a report to indicatewhat he has observed and learnt in the training period. The student may contact the IndustrialSupervisor/ Faculty Mentor for assigning special topics and problems and should prepare the finalreport on the assigned topics. Daily diary will also help to a great extent in writing the industrialreport since much of the information has already been incorporated by the student into the dailydiary. The training report should be signed by the Internship Supervisor and Faculty Mentor.
